The sanction is subject to the fulfilment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes.


1. The school will provide additional suitable facilities for classes XI and XII as per requirements.
2. It will increase the number of books in the library and equipments in the laboratories/work shops with adequate games facilities etc. in consonance with the requirements of the Board for classes XI and XII.
3. It will appoint only qualified staff to teach classes XI and XII as per requirements laid down by the Board.
4. It will provide for adequate co - curricular and extra-curricular activities for the wholesome developments of the students.
5. It will abide by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
6. It will remit Annual Fee Rs. 1000/- regularly. (In case of overseas Independent Schools @ Rs. 5000/- p.a. and overseas Kendriya vidyalayas @ Rs. 3500/- p.a.).
7. As per Annexure 'A'

Special conditions, if any :-

1. DA must be further raised from present 40%.
2. Teachers Orientation Workshops in content and methodology must be arranged.
3. More books of +2 stage in Science and Commerce Should be added to the Library.
4. Three untrained teachers should be asked to undergo Teacher Training or replaced.
5. The reserve fund should be in Joint name and not as either or Survivor as at present.




